Short term auto parking in any of the non-fenced, short-term parking lots shall be on short terms only. Any auto parked in excess of 14 days in any one calendar month, whether continuous or aggregate, shall be considered long-term and will be required to pay the daily rate in excess of the 14 day maximum.

Monthly tie-down and hangar fees exclude commercial aircraft.

Commercial aircraft fees are defined within a Commercial Operating Agreement

First three (3) nights of tie-downs are waived with any fuel purchase, non-commercial aircraft only.

Monthly rates are applicable to any non-commercial aircraft if prepaid in full, prior to the first of the month.

Operators with a Commercial Operating Agreement are exempt from Landing Fees.

Late fees are charged each month per past due invoice and are cumulative.

Aircraft fueled from fueling vessels or tanks other than those owned by the Town of Springerville shall pay a fuel flowage fee per gallon of tank capacity, each fueling operation. Flowage fee will be waived if fuel in non Town-owned tanks is purchased from the Town of Springerville.
